| 1.1 <i>Blitz Rescue</i> establishes the adoption fee at:\$ for this dog, which will help to cover expenses incurred for veterinary care and daily maintenance. This adoption fee is not a sale price and is not refundable under any circumstances. |   |  |

circumstances no longer permits the Adopter to take care of the dog. **Under NO CIRCUMSTANCES** can this dog be given away, sold or abandoned at a pound, SPCA/Humane Society or any other shelter. The Adopter must contact *Blitz Rescue* if he can no longer keep the dog. The Adopter who fails to respect this condition exposes himself to civil action for breach of contract, in accordance with the laws in force in the Province of Quebec.

1.2 Any dog adopted from Blitz Rescue must be returned if it does not fit the adopter's situation or if

- 1.3 In no circumstances will this dog be tied out without direct supervision or kept outside on a permanent basis.
- 1.4 *Blitz Rescue* shall not be held responsible for any damage, injury or expenditure resulting from the dog's ownership.

1.5 Any dispute arising out of and pertaining to the interpretation or the implementation of this contract shall be submitted to the exclusive jurisdiction of the courts of the judicial district of Quebec, Province of Quebec.

## 2. Health and temperament assessment:

- 2.1 *Blitz Rescue* assesses to the best of its abilities the health of dogs made available for adoption. A veterinarian evaluates the dog's well-being by means of a general physical examination. Any health condition detected during this initial examination or during its stay at *Blitz Rescue* is dealt with according to the veterinarian's recommendations. If a known health condition is not treated at the time of the adoption, the Adopter is made aware of this.
- 2.2 The Adopter understands that dogs that come under the care of *Blitz Rescue* are sometimes found as strays or do not have a veterinary file and that certain health conditions might be asymptomatic and may not be diagnosed by our veterinarian. Also, some may have been victims of neglect or mistreatments in the past, which could affect their temperament or behavior in the future.
- 2.3 Unless stated otherwise, any dog made available for adoption by *Blitz Rescue* has been vaccinated, dewormed, micro chipped and spayed/neutered. A health record which lists the care provided is given to the Adopter.
- 2.4 Blitz Rescue evaluates to the best of its knowledge the temperament of dogs made available for adoption. Our foster families provide us with a thorough description of the dog's behavior in their home environment and any observation is provided to the adopter. The Adopter has been made aware of this information, has been given answers to any questions he might have had and consciously commits to the adoption process by being willing to make the necessary efforts to enable the dog to adapt to its new home environment.
- 2.5 The Adopter commits to taking necessary measures to educate the dog in a positive manner, by means of non-violent techniques, and to request the help of a behavior specialist, should difficulties arise.
